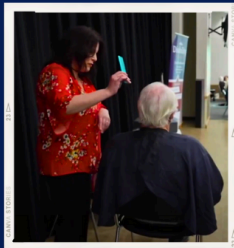

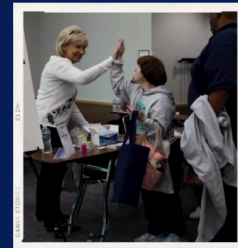

Understanding Recent Social Security Changes



In the realm of Social Security, even long-standing programs like this can undergo significant changes from year to year. Staying informed about these changes is crucial, whether you're currently receiving benefits or contributing to the program through taxes. Here are some key Social Security updates for this year.

1. **Increased Benefits:** Social Security benefits received a 3.2% boost at the beginning of 2024 to account for inflation.

2. **Earnings-Test Limit:** The earnings-test limit, which affects those working while receiving benefits before reaching full retirement age, has risen.

3. **Tougher Work Credits:** Earning work credits for Social Security qualification has become more challenging, with one work credit now valued at \$1,730 in 2024, up from \$1,640 in 2023.

4. **Increased Wage Cap:** The wage cap, determining the amount of income subject to Social Security taxes, has increased to \$168,600 in 2024, up from \$160,200 in 2023.

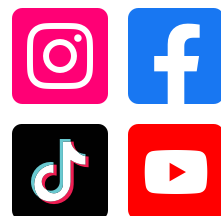
