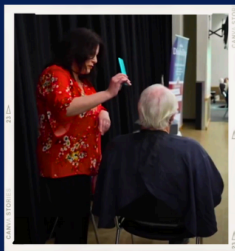

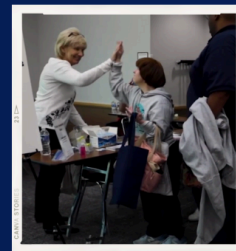

Great news for veterans receiving Department of Veterans Affairs (VA) disability payments - a 3.2% raise in benefits is on the horizon for 2024! In addition to the standard VA disability pay, veterans may be eligible for Aid and Attendance and Housebound benefits. These benefits are designed to cover the cost of in-house care, nursing home care, and assisted living.

To stay informed and maximize your veteran benefits, it's crucial to keep up with the ever-changing landscape of military benefits. Stay updated with DLG to always hear the latest!
