His client served in both the Air Force and the Army, and he developed significant hearing loss and tinnitus with vertigo in service, resulting in a diagnosis of Meniere's Disease.

After various denials and a hard fought battle, Attorney Pearson was confident in his argument and raised all issues in a higher level review. He advocated for his client and soon later, the VA issued a new decision which granted a rating of 100% for Meniere's Disease effective November 2010. 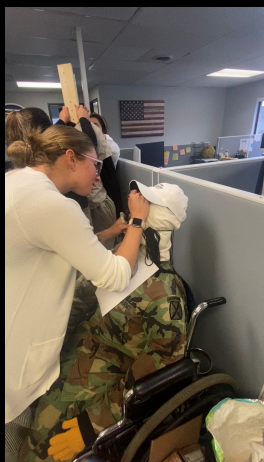

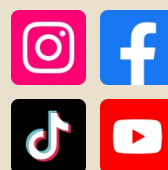
Join us at the 2022 Great Lakes Special Needs Symposium!
